BIB Property Owners Association Board of Directors Meeting Minutes

July 11th, 2019

1. Call to Order

a. Ann McGregor called to order the regular meeting of the BIB Property Owners Association, Inc. Board of Directors at 10:03 am EST/8:03 am BZT, via FreeConferenceCall online meeting.

3. Administrative

a. Marvin sent minutes for June – Bryan and Kathie didn't read them yet – Marvin will resend June Meeting notes; they are also on the Google Drive.

4. President's Report

- a. Ann reviewed HOA board rules and how things are administered.
 - i. Explained board rules. Owners are welcome to board meetings.
 - ii. We have 128 lots in BIB. One vote per lot.
- b. Need for Florida Registered Agent

- i. We are a Florida as an HOA Corporation it has no State income tax. If we were in incorporated in Belize, we would have to pay GST tax.
- ii. We therefore have to maintain a Florida registered agent.
- iii. Our Attorney sent a proposal to be our FL Registered Agent for \$250 USD.
- iv. Motion made to have attorney be our Florida Registered Agent for \$250 annually.Motion passed.

c. Banking resolution & Check Signing

- i. We do have a checking account with Atlantic Bank
- ii. When Ann is in BIB in Sept. she will go with Bryan and Kathie to the bank to update signatures.
- iii. In the meantime, Renie Brady is still on the account as a signator.
- iv. Propose banking resolution that we authorize Renie Brady to sign checks under the direction of the board from our Atlantic Bank Account until such time as other board members are authorized.
- v. Resolution passed.

d. Property Maintenance

- We are no longer calling it Property Management, as the board is handling management functions. Property Maintenance is a better description of the services we contract for.
- ii. Our current Property Maintenance company is not fully successful.
- iii. Kathie's payment processes are being questioned by the Property Maintenance company. Ann feels that we have legal risk exposure due to their correspondence.
- iv. Kathie and Bryan do not feel we have a legal risk. We are not going to ask an attorney for our legal risk exposure. Ann went on record saying that she felt it is the best interest of BIB POA to ask our attorney to review the risk exposure but it is 2 to 1 against doing so.

5. Treasurer's Report - Kathie Miller

- a. We have had a few dollars roll in. We are in the same state as were last year at this time.
- b. We have about \$50,000 USD for the remainder of the year.
- c. Hoping to get another \$10,000 USD by the end of the year.
- d. Reconciliation is up to date as of June 30th
- e. 2019 Budget in Process, 65 lots have paid in full
- f. In all accounts we have \$163,000 BZD including reserve. We agree that we keep \$60,000 BZD in reserve. That leaves about \$103,000 BZD for the rest of 2019. \$20,000 BZD is earmarked for Eagles Landing and \$3,000 left for internet expenses and other budgeted items. We anticipate \$80,000 of expenses for the rest of the year. Bottom line, it looks like we have enough for the highest priority items for the year as well as the two new initiatives added to today's agenda.

- g. We bought a new tractor we have a proposal to build a shed to cover it and put it in the milpa by where we have \$3,272.50. Made motion to budget \$3,500 for a tractor shed. Passed 3 to 0.
- h. From the internet team we have a proposal to do some upgrades to put a more rigid pole and anchor guidewires into rock or concrete footings. Price estimate is \$1,200 to \$1,500 US. Passed resolution to budget \$3,000 BZD for that purpose which passes 3 to 0.
- i. Ann wanted to expand board membership to 5 members as recommended for 2019 and this was not supported by other board members.
- j. The board unanimously agreed that we need an odd number of board members to avoid ties.
- Kathie and Bryan were elected last Sept. to three-year terms. Once elected to the board by the members, the board elects the officers: President, VP, Secretary and Treasurer.
 Currently there are four executive positions and one member at large. Bryan is the member at large.
- I. Every board member's vote is equal. The officers are responsible for extra duties as outlined in the Roles and Responsibilities document on the website.
- m. We don't have the members of the committee on the website. We are getting a lot of questions in chat (please see 'chat' below minutes).
- n. To find our documents, login to the owner website: under Community Documents, select CC&Rs, Bylaws, etc. to find all governing documents.
- o. We currently have 5 board positions. Ann McGregor's and Sandi Smith's terms expires Dec. 2019, Sandi is currently on medical leave. Ann is President. Jenny was on the board and resigned her term expires Dec 2020 and is currently vacant. Kathie and Bryan were recently elected to the board starting in 2019. Kathie is the Treasurer. We have 3 active board members. We have one vacant position and one on medical leave.
- p. Committees: Standards committee is anonymous by choice. They don't mind being named if it is agreed by all members that they will not be individually harassed by owners. We are all volunteers and community members.

6. Committee Status Updates

- a. EAB: Doug, Renie and Melissa Freedman. They make recommendations to the board.
- b. We have removed 10 trees that shaded our fruit trees.
- c. You can see EAB status on our website

7. Gardens – Beth Weary

- a. We got permission to take down the 10 trees and we have done that and they are all cleaned up.
- b. I appreciate all of the help from members who helped out.
- c. We are low on chairs for garden share.

- d. Kathie said that we can have the chairs from her patio on a permanent basis. Kathie may borrow them when she needs them on a rare occasion.
- e. Let's talk about taking out the tank for fish next month where the garden share happens.

8. Roads – Bryan Weary

a. Nothing new on the roads except that we should wait until we have some rain before they are smoothed. Jorge and Eduardo gave Bryan that recommendation. Also, it cuts down on dust.

9. Safety – Gina McCarthy

- a. Gina has inventoried all of the items needed for the first aid kit. There is approximately \$1,000 in the budget for this. Gina will communicate with Dr. Anello about him bringing some supplies in.
- b. Linda is on the committee with Gina.

10. Communications – Ann McGregor

a. We have no chairman. We are working to get the tower more secure.

11. Other Business

- a. HOA documents to review: The covenants is signed by all new buyers, and page numbers can be confusing as they start at 6 and go through 15 of 19 pages the first 5 pages are your title and the pages following the covenants are for signatures and stamps.
- b. Articles of Incorporation describe how the HOA is organized as a corporation. They will be put on the website.
- c. Bylaws describe how the board and organization operates (meetings, notices, elections, etc) and can be changed by the board.
- d. Rules & Regulations talks about how the community operates, how we handle enforcing rules and guidelines for using community spaces. It is a living document and is the lowest in the hierarchy of documents. Any conflict with the covenants the covenants will win.
- e. Owners have different goals and different interpretations although we all want to live with fewer rules, as a board we have a fiduciary responsibility and are required to manage things legally.
- f. We can't pick and choose on enforcement. We all agree that rules are enforced evenly and fairly.
- g. A membership meeting can be requested by owners if needed.

12. Membership Forum:

i. Kathie wants to address the interest fees. In our CC&R, you have 60 days to pay your HOA fees, or a portion of your HOA fees. If nothing is paid 60 days out, the

- owner incurs a 1% charge per month from January. People are now getting their bills that shows late fees. If you don't pay fee the entire year, the total late fee on \$1,000 would be \$120. (Amended 7-18-2019: 1% charge on late HOA fees for US \$1,000 when the owner did not pay for the entire year is US \$1,126.94)
- ii. Suzanne has complaint that she wasn't given enough time to comply with a decision regarding enforcement of vaccinating her dogs. Suzanne said that if we are going to that strict, all rules must be followed including no hummingbird feeders [feeding wildlife], etc.
- iii. Kathie went over timeline and flowchart for violations. There was no third notice because Suzanne got her dogs vaccinated, thus closing the incident.
- iv. The board will be looking at the issue of generators. The covenants say that generators should be used for emergencies only. This is unclear and they will look at defining this better. Sue Waite explained that she needs to run her generator for maintenance purposes which is fine.
- v. Ann said that the best situation is that people will work together to solve their problems.
- vi. Jenny says that the standards committee said that the cicadas are louder than a nearby generator and that was a flippant response and she didn't appreciate it.
