In response to your email:

- 1. You made the claim that after the recent rain, roads being graded faired poorly, while roads not being graded were fine. The fact that Eagles Landing and Howler Hill have been regularly graded, and were not affected by the recent rain prove otherwise.
- 2. The idea behind grading is to move material back onto the road that has washed off the sides. We only grades the roads when they have a little bit of moisture so that the material will stay put while it's being packed back down by regular use. That we have not needed to add additional material to the roads this year proves the success of this method.
- 3. Material was added to the roads back in March, 2019. The tractor was purchased in May 2019 because after 2 months, the top of Forest Hill Drive had such a tilt that many owners considered it unsafe. Therefore, we have been grading the roads now for over 16 months. If regular grading caused the material to be washed away, it would have been gone a long time ago.

- 4. None of the current Board members, the EAB, nor the current maintenance crew had anything to do with the dredging of the pond back in September, 2019 which is most likely the cause of its deterioration. The pond had filled with sand long before the recent rain.
- 5. The collection agency is relevant because it is another example of something the Board did that you oppose, but which will benefit you. The increased money brought in just from the announcement of the collection agency will allow us to put a hard surface on most of the steep hills. At least as of this moment, this is something the Board is doing that you are in favor of. In all honesty, it appears that no matter what the Board does, you instinctively oppose it merely because the Board is in favor of it.
- 6. Your assertion was that Bryan was using the tractor merely because it was "fun" for him. We can assure you all the work the volunteer Board and committee members do is not "fun". Certainly the time we spend responding to your constant complaints and steady stream of vitriol directed towards the BIB POA Board is not "fun".
- 7. It is ironic that you are suddenly interested in volunteering in the garden, when recently you were opposed to the Board spending any money on the garden (<a href="https://bibhoa.com/forums/topic/community-gardens/">https://bibhoa.com/forums/topic/community-gardens/</a>).
- 8. As far as what you can do to help the BIB POA, we would be happy if you reduced your steady barrage of emails and

complaints. We welcome comments, criticism, and suggestions when they are made constructively. But in our view, your repeated complaints are made just to complain and criticize, not to help improve anything. No matter what, we will continue to listen and respond if necessary to everything you send us, but if you want to help, a reduction would be appreciated.

Finally, you are the only person who has complained about the current state of the roads at BIB. All the other comments we have received have been positive, and have come without solicitation. Apparently your dissatisfaction with our roads is a recent phenomena, since you told Beth Weary last January how you were pleased with the state of Forest Hill Drive.

The Board considers this topic closed and will not respond to further emails, unless new information is provided.
